The personal data collected on this form will be held securely and will only be used for administrative purposes. You have the right to request to see a copy of the information we hold about you and to request corrections or deletions of the information that is no longer required. You can ask the University to stop using your images at any time, in which case it will not be used in future publications but may continue to appear in publications already in circulation. If you have concerns about the use of your image this should be raised with the University's Data Protection Officer infoassurance@worc.ac.uk. You have the right to lodge a complaint against the University regarding data protection issues with the Information Commissioner's Office ico.org.uk/concerns. I release and discharge the photographer and the University (and, where applicable, their respective licensees) from any and all claims and demands arising out of or in connection with the use of the photographs, including, without limitation, any and all claims for invasion of privacy, right of publicity and defamation.
